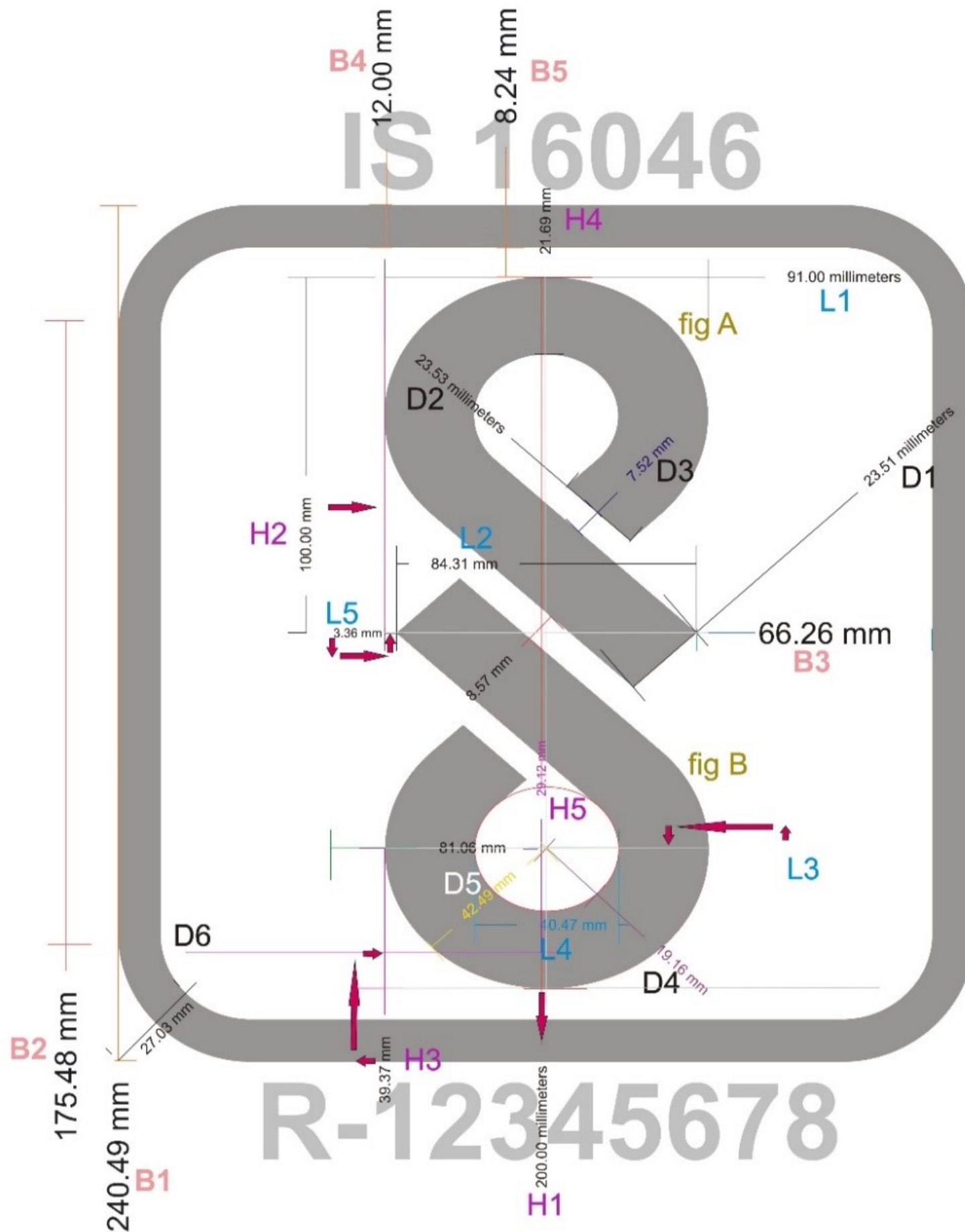

It shall be legible, indelible and non-removable. Further, the durability of marking shall be as per the provisions of the relevant Indian Standard, wherever applicable. The display of IS number, Registration number and words shall not be less than Arial font size 6.
- iv) Any device with a integrated display screen may present the Standard Mark electronically (e-labelling) in lieu of a physical presentation on the product.
